

On September 5, 2017, U.S. Attorney General Sessions Jeff Sessions, on behalf of the entire Trump administration, announced the end of the Deferred Action for Childhood Arrivals (DACA) program. Based on the guidelines released by the Administration, an estimated 10,000 New Yorkers are eligible for renewal if they file by **October 5th**. We know that many students are DACA recipients and they are concerned, so the [New York Immigration Coalition \(NYIC\)](#) is pleased to inform you that **FREE** legal services will be available statewide on a **September 25th Day of Action**.

The New York Immigration Coalition (NYIC) together with Immigrant Justice Corps, the Mayor's Office of Immigrant Affairs (MOIA), the Community Justice Clinic at the UB School of Law, and the New York City Council announced the Immigrant Advocates Response Collaborative (Immigrant ARC) legal defense action plan for Deferred Action of Childhood Arrivals (DACA) recipients. There are 41 participating organizations hosting at least 28 events and counting.
